PURPOSE

Under section 70(a1) of the Local Government Act 1999, Council must publish on its website, in accordance with the Regulations, the following details about a Council Member as recorded in the Register of Interests:

- The Member's income sources (within the meaning of Schedule 3 of the Local Government) or employer;
Schedule 3 - **income source**, in relation to a person, means—
 - (a) any person or body of persons with whom the person entered into a contract of service or held any paid office; and
 - (b) any trade, vocation, business or profession engaged in by the person.
- The name of any political party, any body or association formed for political purposes or any trade or professional organisation (within the meaning of Schedule 3) of which the member is a member
Schedule 3 – S2(3)(b) the name of any political party, any body or association formed for political purposes or any trade or professional organisation of which the member is a member;
- Any gifts received by the member that are required to be included in the information entered in the Register in relation to the member/
Schedule 3 - S2(2)(d) particulars (including the name of the donor) of any gift of or above the amount or value of \$750 received by the member or a person related to the member during the return period from a person other than a person related by blood or marriage to the member or to a member of the member's family; and
