### 187.3 TEMORA LANE - CHANGE OF DESCRIPTOR

## **Purpose**

To seek Council endorsement of a change of descriptor of Temora Lane to Temora Way.

## **Background**

Council will be aware that a reconstruction of Temora Lane now forms part of the entrance road into the new Thomas Foods development. Temora Way is a new 2.2km road that will provide access to the new Thomas Foods International processing facility from Mannum Road. It has been designed to accommodate road trains and regular car traffic (which is anticipated to be around 2,000 car movements when the site is fully developed). By considering road trains in the design and construction of this new road, the new meat processing facility will have the ability to operate at peak capacity which will in turn deliver long term economic benefits for the Murraylands region.

The reconfiguration of Temora Lane and the new road construction connecting with Mannum Road is provided as **Attachment 1**.

Temora was also the name given to the Mobilong West School built in 1904 and renamed in 1908 with a further name change in 1921 to Pallamana School

## **Proposal**

It is considered that the name of Temora should be retained with the descriptor being upgraded from Lane to Way.

Lane is described as a narrow way between walls, building or a narrow country or city roadway.

Way is described as a roadway affording passage from one place to another, usually not as straight as an avenue or street and is an appropriate description of the altered road way.
